(ii) M.Ed.degree from a recognised university with minimum 55% marks;

(iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SL. For who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 their amendments from time to time as the case may be exempted from NET/SET.

(i) Post graduate (M.A.) degree in Education with minimum 55% marks:

(ii) B.Ed. BIL.Ed. degree with minimum 55% marks:

(iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SL 1 or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. Ph.D. Degree) Regulations, 2009 or 2016 their amendments from time to time as the case may be exempted from NET/SET

- A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19th September, 1991.
  - A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
